Raúl Delgado Wise, Ph.D. is Director of the Doctoral Program in Development Studies at the University of Zacatecas (Mexico) and Executive Director of the International Migration and Development Network. He is author/editor of 14 books and more than 100 essays, including book chapters and refereed articles. Dr. Delgado has been guest lecturer in Canada, the United States, Denmark, Switzerland, Germany, the Netherlands, and Great Britain, Italy, Spain, Ghana, and Latin American countries. He received the annual prize for economics research “Maestro Jesús Silva Herzog” in 1993. Currently he is a member of the Mexican Academy of Science, the National System of Researchers, and of several scholarly associations in Canada, the United States, Latin America and Europe. He is editor of the Journal *Migración y Desarrollo*, member of the editorial committee of several academic journals in the US, Chile, Argentina and Mexico, and editor of the book series “Latin America and the New World Order” for Miguel Angel Porrúa.

Rodolfo García Zamora, Ph.D. is Doctor in Economic Sciences by the Universidad Autónoma de Barcelona. Professor-Researcher of the Doctoral Program in Development Studies. His areas of research are migration, remittances and regional development, and rural development. He has been The Director of the Faculty of Economy, and Academic Secretary of the Universidad Autónoma de Zacatecas. He is an advisor to the Consejo Nacional de Ciencia y Tecnología, CONACYT, UAM-Iztapalapa, and Colegio de la Frontera Norte and university professor in Mexican and Spain. Author of *Migración, remesas y desarrollo local* (Universidad Autónoma de Zacatecas, 2003); *Crisis y modernización del agro mexicano* (Universidad Autónoma de Chapingo, 1993); *La agricultura mexicana en el laberinto de la modernidad* (Facultad de Economía-UNAM, 1997); *Agricultura, migración y desarrollo regional* (Universidad Autónoma de Zacatecas, 2000), author and co-author of several books and articles in different academic journals.

Jose Angel Gutierrez, Ph.D., J.D. is a Professor of Political Science at University of Texas at Arlington. He has written numerous articles and several books, including *The Making of a Chicano Militant: Lessons from Cristal*, *They Called Me “King Tiger”*, and *the Chicano Manual on How to Handle Gringos*. He was a leading Chicano activist and political leader in the 1960s and 1970s and one of the co-founders of La Raza Unida political party that helped to raise public consciousness of Chicano civil rights issues. Dr. Gutiérrez has received many honors including being named as one of the “100 Outstanding Latino Texans of the 20th Century” by *Latino Monthly*, January 2000, and “Distinguished Texas Hispanic” by *Texas Hispanic Magazine*, October 1996. He received the Distinguished Faculty Award from the Texas Association of Chicanos in Higher Education in June 1995, and the National Council of La Raza's Chicano Hero Award in 1994.

Matthew Krystal, Ph.D. is Assistant Professor of Anthropology at North Central College in Naperville, Illinois. His current research interests reflect his training at Tulane University, dissertation and continuing fieldwork in Highland Guatemala and more than ten years of work in suburban Chicago English as a Second Language (as teacher, administrator, and volunteer tutor. In addition to scholarship, Professor Krystal is a faculty consultant to North Central College's traded coffee and craft project regularly leading groups of students on trips to highland

Guatemala to meet and work with small-scale coffee farmers and household-based craft producers.

Nancy A. Naples, Ph.D. is Professor of Sociology and Women's Studies at the University of Connecticut, teaches courses on gender and politics, sexual citizenship, feminist theory, and women's activism and globalization. Her books include *Feminism and Method: Ethnography, Discourse Analysis, and Feminist Research*, *Grassroots Warriors: Activist Mothering, Community Work, and the War on Poverty*, *Women's Activism and Globalization: Linking Local Struggles with Transnational Politics* (co-edited with Manisha Desai), *Teaching Feminist Activism* (co-edited with Karen Bojar), and *Community Activism and Feminist Politics: Organizing Across Race, Class, and Gender*.

Pamela Anne Quiroz, Ph.D. is Associate Professor of Policy Studies & Sociology at the University of Illinois-Chicago, and a fellow at the Institute for Research on Race and Public Policy. Professor Quiroz is the author of *Adoption in a Color-blind Society* (2007) published by Rowman and Littlefield.

Britt Rios-Ellis, Ph.D. is an Associate Professor in the Department of Health Science at California State University, Long Beach and Director of the National Council of La Raza (NCLR)/CSULB Center for Community Health, Evaluation, and Leadership Training. She also serves as the Director of the NCLR Latino Families HIV/AIDS Prevention Project, the Guías de Nuestra Señora de Guadalupe Promotora Project and the Latino Healthcare Professionals Project in the Health Care Administration Program. She teaches courses in Latino health care access and status, human sexuality, community health and maternal/child health promotion. She has worked as a consultant for the Office of Minority Health, the Health Resources Services Administration, NCLR, the Pan American Health Organization, and the Ethiopian Community Development Council.

Thomas E. Ruggiero, Ph.D. is currently an Associate Professor in the Department of Communication at the University of Texas El Paso. His published research appears in journals such as *Communication Education*, *Communication Quarterly*, *Journal of Mass Media Ethics*, and *Journal of Computer-Mediated Communication*, *Mass Communication & Society*, and *Communication for Development and Social Change Journal*.

Brandon Valeriano, Ph.D. is an Assistant Professor at University of Illinois at Chicago. He completed his Ph.D. at Vanderbilt University in 2003 in the field of International Relations. He has previously taught at Vanderbilt and Texas State University.
